A local law Dividing the Town of Duanesburg Into Five Election Districts

Section 1: Pursuant to Section 4-100 of the Election Law of the State of New York the Town of Duanesburg is hereby divided into the following election districts:

DISTRICT #1

BEGINNING at a point approximately 200 feet southwesterly of the intersection of Skyline Drive and Duanesburg Churches Road which point is 200 feet to the West of Duanesburg Churches Road and 200 feet South of Skyline Drive; thence proceeding North on a line following Duanesburg Churches Road and being at all times 200 feet West of said road to its intersection with Batter Street; then continuing to the West along said Duanesburg Churches Road 200 feet to the South of the road to a point where the Chuctanunda Creek crosses Duanesburg Churches Road; thence in a northerly direction to a point 100 feet West of the intersection of the Berne Smith Road with the Mariaville-Montgomery County line road and thence continuing in a straight line northerly to the Montgomery-Schenectady County Line; at a point where said creek crosses said line between the Berne Smith Road and New York State Rt.30; thence in a northeasterly direction along said county line to its point of intersection with the easterly boundary of the Town of Duanesburg; thence southerly along the easterly boundary of Duanesburg to a point approximately 1,000 feet South of Skyline Drive; thence in a south-westerly direction to the point or place of beginning being always more than 200 feet South of Skyline Drive.

DISTRICT #2

BEGINNING at a point approximately 200 feet southwesterly of the intersection of Skyline Drive and Duaneburg Churches Road which point is 200 feet to the West of Duaneburg Churches Road and 200 feet South of Skyline Drive; then proceeding North on a line following Duaneburg Churches Road and at all times 200 feet West of said road to its intersection with Batter Street; then continuing to the West along said Duaneburg Churches Road 200 feet to the South of the road to a point where the Chuctanunda Creek crosses Duaneburg Churches Road; thence in a northerly direction to a point 100 feet West of the intersection of the Berne Smith Road with the Mariaville-Montgomery County line road and thence continuing in a straight line northerly to the Montgomery-Schenectady County line at a point where said creek crosses said line between the Berne Smith Road and New York State Rt. 30; thence in a southwesterly direction along said county line to a point in the Schoharie Creek where it intersects the boundary line between Montgomery and Schenectady County; thence in a southerly direction along the center of said creek to a point 200 feet South of the Western Turnpike; thence in an easterly direction along a line always 200 feet South of said Turnpike to a point 200 feet South of said Turnpike and opposite the intersection of the McGuire School Road with said Turnpike; thence in a northerly direction approximately 400 feet across the Turnpike to a point 200 feet North of said Turnpike; thence in an easterly direction along a line always being 200 feet North of the Turnpike to a point in Delevan Road; thence in a northeasterly direction in a straight line to the point or place of beginning.

DISTRICT #3

BEGINNING at a point approximately 200 feet southwesterly of the intersection of Skyline Drive and Duaneburg Churches Road which point is 200 feet to the West of Duaneburg Churches Road and 200 feet South of Skyline Drive; thence in a northeasterly direction in a straight line to a point on the easterly boundary of the Town of Duaneburg, approximately 1,000 feet South of Skyline Drive, said line being always more than 200 feet to the South of Skyline Drive; thence southerly along the easterly boundary of the Town of Duaneburg to a point near I-88; thence in an easterly direction still along the boundary of the Town of Duaneburg running South of I-88 to a point where said boundary line turns and runs in a southerly direction; thence along said boundary line to its intersection with the Schenectady-Albany County boundary line; thence in a westerly direction along said Albany County boundary line to a point about 200 feet westerly of the Bozenkill Road which point is also the intersection of the Delaware and Hudson Railroad with said county line; thence in a northwesterly direction along said Delaware and Hudson Railroad to a point where it crosses the New York State I-88; thence in a southwesterly direction approximately 4500 feet along the center of said I-88 to a point which is approximately 1300 feet southeast

DISTRICT #3 - (con't)

of the intersection of Cole Road and New York State Rt. 7; thence in a straight line in a northwesterly direction passing through a point 200 feet to the West of said intersection of Cole Road and New York State Rt. 7 to a point 200 feet to the North of the intersection of Delevan Road and the Western Turnpike; thence in a northeasterly direction in a straight line to the point or place of beginning.

DISTRICT #4

BEGINNING at a point on Delevan Road 200 feet North of its intersection with the Western Turnpike; thence in a westerly direction on a line along said Western Turnpike and always 200 feet North of said Turnpike to a point which is 200 feet North of the intersection of the McGuire School Road and said Western Turnpike; thence southerly across said Western Turnpike approximately 400 feet to a point which is 200 feet southerly of the southerly boundary of the Western Turnpike; thence westerly on a line along said Western Turnpike and always 200 feet to the South of said Turnpike to a point which is 200 feet westerly of Youngs Road; thence southerly on a line along Youngs Road and always 200 feet westerly thereof to a point on the Delaware and Hudson Railroad which point is 200 feet westerly of the intersection of the Delaware and Hudson Railroad and said Youngs Road; thence in an easterly direction along the Delaware and Hudson Railroad to a point which is the extension of the southerly boundary of the Village of Delanson; thence in an easterly direction along said extended line and along the southerly boundary of the Village of Delanson and continuing on said boundary as extended to the East across Chadwick Road to a point on the New York State I-88; thence in a northeasterly direction along said I-88 to a point which is approximately 1300 feet southeast of the intersection of Cole Road and New York State Rt. 7; thence in a straight line in a northwesterly direction passing through a point 200 feet to the West of said intersection of Cole Road and New York State Rt. 7 to a point 200 feet South of the Western Turnpike; thence in a Northerly direction approximately 400 feet in a straight line to the point or place of beginning.

DISTRICT #5

BEGINNING at a point on the southerly boundary line of the Town of Duaneburg which is the southerly boundary of Schenectady County with Albany County where it is intersected by the Delaware and Hudson Railroad in the vicinity of the Bozenkill Road; thence in a westerly direction along said southerly County boundary to a point marking the intersection of the Schenectady County, Schoharie County and Albany County Boundary lines; thence in a southerly and westerly direction along the boundary between Schenectady and Schoharie County on its various courses to the southwest corner of Schenectady County; thence in northerly and westerly directions along various courses on the Schenectady-Schoharie County line to a point in the center of the Schoharie Creek; thence along said County

line as it follows the center of said creek to a point 200 feet southwest of the intersection of the Western Turnpike and said Schenectady-Schoharie County line; thence in an easterly direction along a line 200 feet southerly of the Western Turnpike to a point which is 200 feet westerly of Youngs Road; thence in a southerly direction along a line which is always 200 feet to the west of Youngs Road to a point which is on the Delaware and Hudson Railroad right-of-way and 200 feet westerly of intersection of said right-of-way with the Youngs Road; thence in a southeasterly direction along the Delaware and Hudson Railroad to a point where it is intersected by the extension of the southerly boundary of the Village of Delanson; thence in an easterly direction along said extended line and along the southerly boundary of the Village of Delanson and continuing on said boundary as extended to the East across Chadwick Road to a point on the New York State I-88; thence along the center of said I-88 to a point where it is intersected by the right-of-way of the Delaware and Hudson Railroad; thence in a southeasterly direction along the right-of-way of said Delaware and Hudson Railroad to the point or place of beginning.

Section 2: The Town Supervisor shall file a map showing such districts with the Schenectady County Board of Elections.

Section 3: This Local Law shall take effect upon the filing with the Secretary of State as provided in the Municipal Home Rule Law.

Such local law was submitted to the people by reason of a mandatory referendum, and received the affirmative vote of a majority of the qualified electors voting thereon at the special election held on 19, in accordance with the applicable provisions of law.

4. (Subject to permissive referendum, and final adoption because no valid petition filed requesting referendum.)

I hereby certify that the local law annexed hereto, designated as local law No. of 19 County City of was duly passed by the not disapproved on 19 and was approved by the Elective Chief Executive Officer * on 19. Such local law being subject to a permissive referendum and no valid petition requesting such referendum having been filed, said local law was deemed duly adopted on 19, in accordance with the applicable provisions of law.

*Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis or, if there be none, the chairman of the county legislative body, the mayor of a city or village or the supervisor of a town, where such officer is vested with power to approve or veto local laws or ordinances.

5. (City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. _____ of 19 _____ of the City of _____, having been submitted to referendum pursuant to the provisions of § 36 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the special election held on _____ 19 _____ became operative.

6. (County local law concerning adoption of Charter.)

I hereby certify that the local law annexed hereto, designated as Local Law No. _____ of 19 _____ of the County of _____ State of New York, having been submitted to the Electors at the General Election of November _____, 19 _____, pursuant to subdivisions 5 and 7 of Section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.
