A Local Law amending Local Law No. 2 of the year 1989,
Establishing a Mandatory Recycling Program in the Town
of Duanesburg, by adding a definition of the term "resident".

Be it enacted by the Town Board of the Town of Duanesburg as
follows:

SECTION 1 TITLE

This local law shall be known as Amendment No. 1 to the
Mandatory Recycling Law of the Town of Duanesburg.

SECTION 2 PURPOSE

The purpose of this local law is to amend the existing
mandatory recycling law of the town of Duanesburg to include
in its provisions all commercial establishments doing business
or otherwise creating recyclables in the Town of Duanesburg.

SECTION 3 AMENDMENT

Local Law No. 2 of the year 1989 is hereby amended by
adding the following to Section 4 after subparagraph D thereof
(new matter is indicated by underlining):

E. The term resident as used in this Local Law shall
mean any persons, as that term is defined in subparagraph
G herein, who live in the Town of Duanesburg, have an esta-
blishment for doing of business in the Town of Duanesburg,

or otherwise require solid waste service as that term is defined in subparagraph I herein.

SECTION 4 EFFECTIVE DATE

This Local Law shall become effective upon filing with the New York Secretary of State.


