LOCAL LAW NO. <u>1</u> OF THE YEAR 2008 TOWN OF DUANESBURG

January 10, 2008

A LOCAL LAW ESTABLISHING TRAINING REQUIREMENTS FOR PLANNING BOARD AND ZONING BOARD MEMBERS AND ALTERNATE MEMBERS

Motion: <u>Council-member Carlson</u> Second: <u>Council-member Potter</u>

WHEREAS, the adoption and implementation of local land use decisions have a profound effect on the character of a community and the well being of its citizens; and

WHEREAS, the administration of land use laws is a complex and highly diverse process that requires specialized knowledge and familiarity with the applicable laws and regulations; and

WHEREAS, well considered and timely decisions, consistent with those laws and regulations attract quality community development, result in fewer lawsuits and generally decrease the discord within the community; and

WHEREAS, the Town of Duanesburg desires to provide, for the benefit of its citizens, a well trained and knowledgeable body of officials to administer the local land use process;

NOW THEREFORE BE IT ENACTED by the Town Board of the Town of Duanesburg as follows:

Section One. Pursuant to the provision of Town Law §§ 267 and 271, all members and alternate members of the Town of Duanesburg Planning Board ("Planning Board") and Town of Duanesburg Zoning Board of Appeals ("Zoning Board of Appeals") shall complete at least four (4) hours of training per year, as may be approved

in accordance with Sections Two and Three of this Local Law No. _1__ of the Year 2008. Up to two (2) hours of training credit obtained and approved per year in excess of the four (4) hour minimum requirement of this Section One may be carried over and applied by a member or alternate member of the Planning Board or Zoning Board of Appeals to the training requirement of this Section One applicable during the next succeeding year.

Section Two. The Planning Board member serving as Chairman of the Planning Board during the year in which the training credit is to be applied shall approve reasonable and appropriate training courses for members of the Planning Board, including alternate members. The Zoning Board of Appeals member serving as Chairman of the Zoning Board of Appeals during the year in which the training credit is to be applied shall approve reasonable and appropriate training for members of the Zoning Board of Appeals, including alternate members. Approved training courses shall be noted annually in the respective minutes of the Planning Board and Zoning Board of Appeals.

Section Three. The training requirement of Section One of this Local Law No.

1 of the Year 2008, may be satisfied by educational activities substantially devoted to planning, zoning or other land use issues such as: (a) attending conferences, seminars or workshops; (b) participating in on-line training or tutorials; (c) attending college courses; or (d) any other educational activities approved in accordance with Section Two of this Local Law No.

1 of the Year 2008. Training may be offered by a municipality, regional or county planning office or commission, county, regional or state planning federation, state agency, statewide municipal association, college, university, private

institution or other similar entity.

Section Four. An annual record of completed and approved training shall be maintained by the Building and Planning Department of the Town of Duanesburg and a copy provided to the Town of Duanesburg Town Board prior to the re-appointment of any member or alternate member of the Planning Board or Zoning Board of Appeals.

Section Five. A member or alternate member of the Planning Board or Zoning Board of Appeals shall be eligible to be appointed or re-appointed to either such Board only upon the completion of training as required by Section One of this Local Law No.

1 of the Year 2008; provided however, that any new member or alternate member of the Planning Board or Zoning Board of Appeals appointed to fill the last four (4) months or a shorter term of a vacancy on such Board shall be eligible to be appointed or reappointed to either such Board without completing the training required by Section One of this Local Law No. 1 of the Year 2008.

Section Six. Any member or alternate member of the Planning Board may be removed from such Board pursuant to the removal procedures set forth under Town Law for failure to meet the training requirements of this Local Law No. __1_ of the Year 2008.

Section Seven. This Local Law No. _1_ of the Year 2008 shall take effect as provided by law.
