- ✓ Registration opens for each collection the Tuesday following the previous event. You will receive a registration confirmation by email and/or U.S. mail prior to the event. Bring it with you to the collection. Contact us by phone at 386-2225 if you do not receive the confirmation by your mail delivery the day before the event.
- ✓ A compost facility permit is also required to participate in all events. The yearly permit fee is \$20 and the permit can be purchased at the Compost Facility on Hetcheltown Rd. in Glenville or at the Schenectady County Office Bldg., Finance Office, 620 State Street, 3<sup>rd</sup> floor.

Accepted Materials include: Leftover or unused household cleaners, paints and paint related items, lawn & garden chemicals and automobile fluids (except anti-freeze and motor oil). Bring items in their original container with the original label if possible.

- Only material from households can be accepted. Quantities larger than one carload may be rejected. Call 386-2225X9-224 if you have more than 20 one-gallon cans or the equivalent.
- No waste from commercial, industrial, institutional or not-for-profit generators is allowed. These generators can call 386-2225X9-224 for information about getting rid of hazardous materials.

## • Do **NOT** bring the following items:

Motor oil, antifreeze, lighting, batteries, asbestos, explosives (including ammunition), smoke detectors, medical waste, grill-sized propane tanks or larger, electronics, computers or computer accessories, empty aerosol, or empty paint containers. See "Safe Management Alternatives" brochure to learn how to handle these materials. See "Disposing of Home Use Medical Needles" brochure for handling syringes and medical sharps).
