RESOLUTION OF THE TOWN BOARD OF THE TOWN OF DUANESBURG

A RESOLUTION FOR THE PURPOSE OF ESTABLISHING THE DUANESBURG AMBULANCE DISTRICT

WHEREAS, pursuant to Articles 12-A of the Town Law of the State of New York, the Town of Duanesburg is taking the necessary steps to establish a Town wide ambulance district after a public hearing upon notice by the adoption of a resolution of the majority of the Town Board of the Town of Duanesburg, and

WHEREAS, it having appeared to the Town Board of the Town of Duanesburg that the establishment of an ambulance district in order to provide for emergency medical services, including Basic Life Support care and ambulance transportation services, is both necessary and desired in order to provide for the safety and health of the residents of the Town of Duanesburg and transient persons located in the Town, and

WHEREAS, the Town Board has caused to be prepared, filed and/or published where required, a Notice of Hearing, Order, Map, Plan and Report, and a Detailed Explanation as to how the Estimated Rate of Assessment for the Proposed Ambulance District was Computed for the ambulance district proposed to be established, and

WHEREAS, it having appeared to the Town Board of the Town of Duanesburg at the Public Hearing on the matter held on February 27, 2025 that:

- 1) The Notice of Hearing was published and posted as required by law;
- 2) The proposed establishment of the Duanesburg Ambulance District includes all areas of the Town of Duanesburg;
- 3) All of the property and property owners benefitted by the establishment of the proposed ambulance district are located within the limits of the proposed ambulance district; and
- 4) The establishment of the proposed ambulance district is in the public interest.

WHEREAS, the Town Board as lead agency pursuant to SEQRA, 6 NYCRR 617.5(c)(26), determines that this action is a Type II action that will have no impact upon the environment as a "routine or continuing agency administration and management;" and

WHEREAS, the property and property owners within the Village of Delanson are proposed to be included in the ambulance district upon the consent of the Village of Delanson Board of Trustees and upon satisfaction of all statutory conditions precedent to the approval of the establishment of said ambulance district (see attached resolution of the Village of Delanson Board of Trustees); and

NOW, THEREFORE BE IT RESOLVED, that during its Regular Meeting conducted on April 10, 2025 the Town Board of the Town of Duanesburg determined by, and in accordance with this Resolution, that: 1) the Public Hearing concerning the proposed establishment of the Duanesburg

Ambulance District was properly noticed and conducted as required by law; 2) the establishment of the Duanesburg Ambulance District that includes all areas of the Town of Duanesburg, 3) all of the property and property owners benefitted by the establishment of the ambulance district are located within the limits of the ambulance district; and 4) the establishment of the ambulance district is in the public interest; and

BE IT FURTHER RESOLVED, that pursuant to Section 198 (10-f)(e) of the Town Law, the Town Board intends to establish by local law a three-person, appointive District Board of Ambulance Commissioners who shall act in an advisory capacity to the Town Board with regard to the operation of the Duanesburg Ambulance District, who shall serve at the pleasure of the Town Board and whose initial commissioners shall be appointed for a one, two, or three-year term and thereafter, said commissioners shall have appointed and staggered, three-year terms; and

BE IT FURTHER RESOLVED, that pursuant to Section 190 of the Town Law and Article 9 of the Village Law, upon the written consent of the Village Trustees of the Village of Delanson as set forth on the attached resolution, the Duanesburg Ambulance District hereinbefore established will include those parcels and property located within the limits of the Village of Delanson; and

BE IT FURTHER RESOLVED, upon passage of this Resolution and the satisfaction of all condition's precedent, the Town Board does so establish the Duanesburg Ambulance District as so provided for herein; and

BE IT FURTHER RESOLVED, the Town Clerk is hereby directed to post on the website and affix to the public notice board and publish in the newspaper of general circulation an abstract of the resolution within ten days of passage pursuant to NYS Town Law to comply with Article 7 Permissive Referendum requirements; and

BE IT FURTHER RESOLVED, the Town Clerk is hereby directed to file and record a certified copy of this Resolution and any Order issuing here from within ten days after the adoption of such Order, in the office of the Schenectady County Clerk, and to file such Resolution and Order with the NYS Office of the State Comptroller in Albany New York, and to take all actions and perform all acts necessary to implement the provisions of this Resolution and such Order.
