**Agreement**

**Between the Town of Duanesburg and Duanesburg Little League**

**AGREEMENT** (this "Agreement") for services by and between the **TOWN OF DUANESBURG** and **DUANESBURG LITTLE LEAGUE**.

**IT IS HEREBY AGREED** that, for the consideration hereinafter set forth, the Town of Duanesburg, through its Highway Department, will plow snow from the Duanesburg Little League's driveway (approximately 1,300 linear feet) and parking lot (approximately 85'x 375') located at 10179 Western Turnpike, Delanson, New York (collectively the "Parking Lot") during the months of December 2023 through March 2024 for purposes of facilitating public access to the temporary ice skating rink to be placed on Duanesburg Little League property. The Town of Duanesburg shall not have any responsibility other than the removal of snow from the Parking Lot and shall not be responsible in any manner for the installation or operation of the ice rink.

The Town of Duanesburg will provide Duanesburg Little League with proof of insurance evidencing coverage of the work provided for herein. Duanesburg Little League will provide the Town of Duanesburg with proof that the Town of Duanesburg has been added as an additional insured, with waiver of subrogation, on a primary and not contributory basis, to the Duanesburg Little League's insurance policy(ies) with respect to the Town of Duanesburg work pursuant to this Agreement.

In consideration of the above, the Duanesburg Little League shall pay the Town of Duanesburg the sum of One Dollar (\$1.00) for services provided in 2023-2024, and other good and valuable consideration the receipt of which is hereby acknowledged.
