PURPOSE.

The purpose of this local law shall be to govern the review of solar energy facilities and to amend the Town of Duanesburg Zoning Ordinance by providing for the siting, development and decommissioning of solar energy systems subject to reasonable conditions to reduce potential impacts to adjoining properties, while promoting the effective and efficient use of solar energy resources.

In accordance with its Comprehensive Plan, when reviewing solar energy facilities, the town seeks to encourage the preservation of its attractive and cultural landscape, and is committed to sustaining its valuable economic and natural resources, particularly agricultural land use, open spaces, natural habitats and fresh watersheds.

SOLAR LAW APPLICATION REQUIREMENTS

Included in Rotterdam, Schoharie, Sharon, Minden, Copake:

- 1. PE-signed plans
- 2. Plan for clearing & grading *
- 3. Electrical Diagram
- 4. Documentation of accessibility*
- 5. DEC Stormwater Pollution Prevention Plan
- 6. Utility notification
- 7. Photo simulation
- 8. Noise analysis
- 9. Part 1 Full Environmental Assessment Form
- 10. Decommissioning Plan
- 11. Escrow Account for town review

Other frequently required items:

- 1. Legal consent among all parties (e.g. property owner, operator)
- 2. Equipment spec sheet/Inventory of equipment
- 3. Operation & Maintenance Plan
- * = Required by Duanesburg zoning ordinance for site plan approval
