Supervisor Tidball announced that the Duane Lake Association had a meeting to talk about what they can do to improve the water quality of the lake. Superintendent Reed, Council Members Passonno and Potter to met with Allen Knight and see if there is anything the town can do to help divert water.

#### **Committee Reports**

**Highway:** Superintendent Reed reported that they are about half way down with the first round of mowing for the season. Ditches are being completed on Gage Rd. hill and we are getting ready to widen the west shoulder of the road. Also, have been working on cleaning ditches and cutting shoulders on some roads over in Mariaville. New pickup is on the road and being used by the Parks and the larger truck will be on the road in the next few days.

Public Safety: Council Member Senecal had nothing to report.

Parks: Council Member Senecal reported that the restroom project for Van Patten Park is in progress. The septic tank and forms are in place; Council Member Senecal will be lying the rough plumbing tomorrow, so that they can back fill and pour the slab sometime next week. Project will then be put on hold until after the Park Program finishes up. The summer park program is fully organized; Park Director Vanessa Baker is looking for small clay pot donations if anyone has any lying around. Council Member Senecal went up to the point to go over the stone wall project they want to put up there. The Park Commission is also looking for volunteers to open and close the parks daily. Council Member Passsonno to touch base with Dale on water tank for the point.

Sewer District #1, 2 &3: Council Member Ganther reported that he met with the sewer team, Dale and Jamie Malcolm to do inspections at the plant and it went very well. Mr. Malcolm asked about the | & | and we stated that we would be starting inspections with the new camera soon. The team should Mr. Malcolm the software they have on their phones that gives them alerts anytime there are any issues at the pump stations. Mr. Malcolm asked about the infiltration problems we had in the past with the high school; we told him how we put the dye in the drains and everything came out clean at the plant.

Bill Brown from Delaware Engineering reported that they will be asking for approval for the supervisor to sign a WQIP grant application at the next meeting; there is funding in place to pay for up to 75% of a UV disinfection system if it has been mandated by the state in which our case it has. Applications will be accepted until the end of July.

Supervisor Tidball stated that they are planning on doing a little opening ceremony for SD#3 and would like to go to the next Metroplex meeting to give them a big thank you for everything they have done.

**Technology:** Council Member Ganther reported that the next Broadband Committee meeting will be downstairs at Town Hall on July 10th @ 6:30.

Supervisor Tidball reported that he, Council Member Ganther and Superintendent Reed me with a chief surveyor from the Spectrum construction group today along with two of the residents from Arquette Way. All of the utility cables are buried on that road and trenching would need to be done to lay broadband cables. The Supervisor has asked the highway department if they would be willing to do the trenching along that road bringing the cost down and then Spectrum is willing to install broadband in that area which encompasses Arquette Way, Mt. View Lane and parts of Scotch Ridge Road. The highway department will be reimbursed from the money put aside to go towards broadband. Supervisor Tidball also stated that the Spectrum Rep. brought up possible projects on Schoharie Turnpike, Weaver Rd. and Skyline Dr. (maybe on hold due to Verizon possibly coming in that area). Then, possibly doing on Creek Rd. what we will be doing on Arquette to get those residents broadband service.

Please if you currently don't have access to broadband continue to call Spectrum, your congressmen, assemblymen and the Public Service Commission.

#### Additional Items brought to the table:

A list will be put together for next meeting with pictures of possible items to be auctioned off.

A resident brought to the town's attention that there has been a considerable amount of truck traffic on Youngs Rd. lately. We are reaching out to the county to see what can be down to maybe change the weight limit on the road.

### RESOLUTION, June 14, 2018

BOND RESOLUTION OF THE TOWN OF DUANESBURG, NEW YORK (THE "TOWN"), ADOPTED JUNE 14, 2018, AUTHORIZING THE FINANCING OF IMPROVEMENTS AND OTHER COSTS RELATED AND INCIDENTAL THERETO, FOR THE DELANSON WASTEWATER TREATMENT PLANT SERVICING DUANESBURG SEWER DISTRICT NO. 1 AND DUANESBURG SEWER DISTRICT NO. 3; ESTIMATING THE MAXIMUM AGGREGATE COST THEREOF TO BE \$1,773,178.00; APPROPRIATING SAID AMOUNT THEREFOR AND AUTHORIZING THE ISSUANCE OF \$1,773,178.00 SERIAL BONDS OF THE TOWN TO FINANCE SAID COST.

NOW, THEREFORE, IT IS HEREBY RESOLVED, by the Town Board of the Town of Duanesburg (by a favorable vote of not less than two-thirds of all the members), as follows:

#### SECTION 1.

Pursuant to Sections 31.00 and 32.00 of the Local Finance Law, constituting Chapter 33-A of the Consolidated Laws of the State of New York (the "Law"), the Town Board of the Town of Duanesburg hereby authorizes the financing of the construction of improvements for the Delanson Wastewater Treatment Plant servicing Duanesburg Sewer District No. 1 and Duanesburg Sewer District No. 3, including upgrades to the existing wastewater treatment plant systems in order to achieve the benefits of connection thereto and the installation of equipment, machinery, furnishings, fittings, connections and appurtenances related thereto (collectively, the "Improvements").

## SECTION 2

It is determined that this financing is for an assessable improvement and the period of probable usefulness of the aforesaid specific object or purpose is forty (40) years pursuant to Section 11.00(a)(1) of the Law. Pursuant to Section 23.00b-1 of the Law, bond anticipation notes issued anticipation of bonds for this assessable improvement may be renewed beyond five (5) years, provided that such renewals do not extend beyond the period of probable usefulness set forth in this Section 2 of the Resolution.

#### SECTION 3.

The plan of financing the maximum aggregate \$1,773;178.00 cost of the Improvements includes the issuance of \$1,773,178.00 bond anticipation notes or serial bonds and the levy of a tax upon the several lots and parcels of land especially benefited by the Improvements (Duanesburg Sewer District No.1 is comprised of 441.98 equivalent dwelling units (EDU's) and Duanesburg Sewer District No. 3 is comprised of 155 EDU's, for a total of 596.98 EDU's to be benefitted by the Improvements), to pay the principal of and interest on said bond anticipation notes or bonds as the same shall become due and owing. The Town anticipates applying for financing from the New York State Environmental Facilities Corporation through the Water Infrastructure Improvement Act (WIIA) program which could provide the Town with a grant in the amount of 25% of the Improvement costs which, if awarded, would reduce the financing amount of the Improvements.

#### SECTION 4.

The temporary use of available funds of the Town, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized to be expended pursuant to Section 165.10 of the Law for the specific object or purpose described in Section 1 of this resolution. If such temporary funds are used for any expenditure authorized in this resolution, the Town intends to reimburse such funds with the proceeds of the tax-exempt borrowing authorized and identified pursuant to Section 1 above.

#### SECTION 5.

The serial bonds issued to finance the cost of the object or purpose described in Section 1 above shall mature no later than forty (40) years to be measured from the date of the bonds or from the date of the first bond anticipation note issued in anticipation of the sale of such bonds, whichever date is earlier.

#### SECTION 6.

The Town hereby covenants and agrees with the holders from time to time of said serial bonds of the Town issued pursuant to this resolution, and any bond anticipation notes of the Town issued in anticipation of the sale of said bonds, that the Town will duly and faithfully observe and comply with the provisions of the Internal Revenue Code of 1986, as amended (the "Code"), and any proposed or final regulations of the Internal Revenue Service issued pursuant thereto (the "Regulations") unless, in the opinion of Bond Counsel to the Town, such compliance is not required by the Code and the Regulations to maintain the exemption of interest on said obligations from Federal income taxation.

#### SECTION 7.

The Town Board previously declared the construction of the Improvements is a Type II action pursuant to the State Environmental Quality Review Act.

#### SECTION 8.

Each of the serial bonds authorized by this resolution and any bond anticipation notes issued in anticipation of said bonds shall contain the recital of validity prescribed by Section 52.00 of the Law and said serial bonds and any notes issued in anticipation of said bonds shall be general obligations of the Town, payable as to both principal and interest by a general tax upon all the real property within the Town without legal or constitutional limitation as to rate or amount. The faith and credit of the Town are hereby irrevocably pledged to the punctual payment of the principal of and interest on said serial bonds and any bond anticipation notes issued in anticipation of said bonds and provision shall be made annually in the budget of the Town by appropriation for (a) the amortization and redemption of the bonds and notes to mature in such year, and (b) the payment of interest to be due and payable in such year.

#### SECTION 9.

It is intended that this resolution shall constitute an official intent within the meaning of Section 1.150-2 of the Regulations to reimburse the Town with the proceeds of the aforesaid bonds or bond anticipation notes to the extent of applicable expenses paid by the Town prior to the issuance of such bonds or bond anticipation notes.

#### SECTION 10.

Subject to the provisions of this Bond Resolution and the Law, pursuant to the provisions

of Section 30.00 of the Law relative to the authorization of the issuance of serial bonds and bond anticipation notes, or the renewals of said obligations and of Section 50.00 and Section 60.00 of the Law, the powers and duties of the Town Board of the Town relative to authorizing serial bonds and bond anticipation notes and prescribing the terms, form and content as to sale and issuance of the bonds herein authorized and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said notes, are hereby delegated to the Supervisor of the Town, the chief fiscal officer of the Town. Pursuant to the provisions of paragraph a of Section 56.00 of the Law, the power to determine whether to issue bonds and bond anticipation notes having substantially level or declining annual debt service, as provided in paragraph d of Section 21.00 of the Law, is hereby delegated to the Supervisor of the Town, the chief fiscal officer of said Town. In addition to the delegation of powers described above, the powers and duties of advertising such bonds for sale, conducting the sale and awarding the bonds, are hereby delegated to the Supervisor of the Town, who shall advertise such bonds for sale, conduct the sale and award the bonds in such manner as he shall deem best for the interests of the Town; provided, however, that in the exercise of these delegated powers, he shall comply fully with the provisions of the Law and any other order or rule of the State Comptroller applicable to the sale of municipal bonds.

#### SECTION 11.

All costs and expenses in connection with the acquisition and development of the object and purpose set forth in Section 1 above, and the financing thereof by the sale of bonds, including but not limited to, the fees and expenses of bond counsel, financial advisors, underwriters feasibility consultants, counsel for the Town and other professionals, shall be paid to the extent permitted by law from the proceeds of the sale of such bonds.

#### SECTION 12.

The Town hereby authorizes its Supervisor to enter into any and all agreements, including but not limited to agreements with the Environmental Facilities Corporation, as may be necessary and proper to carry out the intent of the foregoing resolution.

#### SECTION 13.

The validity of the bonds authorized by this bond resolution and of any notes issued in anticipation of said bonds may be contested only if:

- (a) Such obligations are authorized for an object or purpose for which the Town is not authorized to expend money, or
- (b) The provisions of law which should be complied with at the date of the publication of such resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication, or
- (c) Such obligations are authorized in violation of the provisions of the constitution.

#### SECTION 14.
