A majority of such members shall be persons other than Town Board Members, Town Officers or Town Employees but shall include at least one member who is an elected or appointed officer or employee of the Town of Duanesburg. Of the total membership of the Board of Ethics, no more than a majority of the members shall be registered in the same political party;"

WHEREAS, there is a vacancy on the Board;

Re: Privilege of the Floor Ethics Board and Legal Representation

Dear Supervisor Wenzel,

1. The town website appears to be missing some information:

A search of the town website does not provide the 2009 Ethics Law which is referred to in Local Law 1 of 2010 "Superseding Local Law 1 of the Year 2009 to the Enactment of a Code of Ethics and Establishment of a Board of Ethics for the Town of Duanesburg" which was filed with New York State Department of State on January 22, 2010.

A search of the town website does not provide the town's Fraud Policy, Resolution 71-20 "Town of Duanesburg Fraud Abuse Awareness Policy" which was adopted May 14, 2020.

Incomplete and inaccurate listing of local laws and policies may open the door to impropriety. I request that these items are added to the "Town Code" webpage.

2. On January 28, 2020 I e-mailed the town clerk to request the Agenda for the February 1, 2020 Ethics Board meeting.

February 4, 2020 the town clerk emailed me "There are no agendas or minutes taken at Board of Ethics Meetings due to them being in Executive Session."

Does the Ethics Board conduct all business in executive session? Are there any records of Ethics Board meetings, meeting dates, and business conducted?

While I don't expect a response from the board this evening I do request a written response to my questions.

3. On August 13, 2022 the Schenectady Gazette published Ethics Board member Toni Dicaprio's obituary. The January 3, 2023 Town Board Organizational Meeting Minutes appointed Tammy Arquette, Jean Frisbee, Lorri Meyers and Town Board member Rick Potter to the Ethics Board.

Why has the town board waited 10 months to appoint a fifth member to the Ethics Board? Is the Ethic Board currently conducting business that requires board member action?

4. The town website and town meeting minutes do not appear to include any information or postings for nominations to fill a vacancy on the Ethics Board. It appears that meeting minutes do not reflect public discussion for nominations to the Ethics Board.

Some may say that tonight's appointment of James Mugits may be hand picked by the town board.

Lack of transparency and accountability for opportunities to serve the town may open the door to impropriety and fraud. I urge the town board to post open board positions on the town website, announce vacancies at meetings and hold open nominations. This would fully and freely inform the public of opportunities to participate in their local government.

5. At the April 13, 2023 Town Board meeting a resident drew the board's attention to Teressa Bakner of Whiteman Osterman and Hanna being counsel for the town board, planning board, zoning board and ethics board. Having one source of legal representation does not provide a system of checks and balances. It may create the opportunity for impropriety and fraud.

I request that the town hire separate legal representation for the ethics board and separate legal representation for the town board. Having multiple sources of legal counsel may provide transparency and accountability. It may protect the town, the taxpayers monies, and taxpayers from improper behavior at town hall.
