Pledge of Allegiance

Public Hearing: The Preliminary Budget for the Town of Duanesburg for the fiscal year beginning January 1, 2020.

Supervisor Tidball read the public notice published in the Gazette.

Supervisor Tidball stated that there were a lot of things that went into doing the budget this year. We are looking to add 9 new computers this year to replace outdated equipment at approximately \$10,000. We will be using fund balance funds in our highway department to help purchase some equipment. At the end of the day we will not be exceeding the 2% tax cap. At first it had looked like we were going to and that is why we proposed the local law to exceed the tax cap just to be prepared in the event that we needed to. With some other cuts and final numbers received back from the fire departments and health insurance premium quotes we were able to keep it under. The Town tax will be a 3.12% increase and the highway tax will be a 2.54% increase. In 2019 were \$92.59 per \$100,000 and the 2020 proposed budget will be \$95.12 per \$100.000, which is a \$2.53 increase.

Supervisor Tidball motioned, seconded by Council Member Senecal to open the floor for comments.

Motion carried, 3 ayes

Resident Bill Park of Maranatha Way would like to thank Supervisor Tidball for delivering the Annual Report to his office. He stated that he is not happy that we are not spending down more of the surplus. He mentioned that he received the Princetown newsletter, because he owns a building in Princetown noted in the newsletter from the Supervisor it states that the town board has been working on the 2020 budget and once again no town tax. He would like to see us work more closely to that. Mr. Park stated that he saw nothing in the annual report that referenced the \$300,000 loan from the general fund to the sewer district. He feels that should be included in case the current board members are no longer available to refer to. Mr. Park brought up some questions on our collateralization. Supervisor Tidball responded that he will look into it further.

Resident Tom Collins of Weast Road asked if we had a fund balance in the town and why we aren't using it. Supervisor Tidball responded with we think of it as a savings account in case something were to happen, the town would not need to go to a bank and borrow money to then pay additional interest fees. Mr. Collins would like to commend the board for having the public hearing notice put on the town website. Mr. Collins asked if the Supervisor's Office was fully staffed, since he noticed a drop ion the bookkeeper salary, but noticed that a fiscal agent was added in. Supervisor Tidball responded with instead of having a full-time bookkeeper her we are using an outside source to handle all our Accounts Payable.

Supervisor Tidball motioned, seconded by Council Member Leoni to close the floor for comments.

Highway: Council Member Potter reported that the last two weeks the guys have been out adjusting manhole covers, so the plows don't get destroyed. Public Safety: Council Member Leoni reported that there weren't any meetings. There is a need for volunteers in the ambulance corp and the fire districts. DVAC is holding a turkey dinner tomorrow. Council Member Ganther reported that Burtonsville sent out notices to everyone in their district notifying them of what fire district they live in and what to do in the event of an emergency.

Parks: Council Member Leoni reported that they have not had a meeting. Members are needed on the Park Commission.

Sewer District #1, 2 &3: Council Member Senecal reported that there isn't too much going on. The sewer team did find another infiltration leak up near Mariaville Lake near one of the pump stations. Weather permitting, they were going to have it cleared up this week. Other than that, just standard maintenance issues. Supervisor Tidball reported that we are moving along on the closing for the Sewer District #3 financing.

Technology: Council Member Ganther reported that the next broadband meeting will be in December. He will get the exact date and announce it at the next meeting. Supervisor Tidball reported that we were still waiting on the final word to finish up one project on Mt. View and Arquette Way. Verizon has been running fiber optic near Eaton Corners. Millers Corners and Route 30.

Additional: Supervisor Tidball reported that he went to the village meeting the other night. The Village is in the early stages of looking into expanding and upgrading their water system to help the elementary school. They are developing a preliminary plan with their engineering group.

Resolution 141-19: Supervisor Tidball motioned, seconded by Council Member Senecal to appoint Jon Woodworth as a Motorized Equipment Operator with a start date of November 4, 2019. Motion carried, 5 ayes

Jane Weyers of Knight Rd. stated that after reviewing other local towns solar laws. She respectfully requests that the town out a moratorium on any future solar projects until the town can review the current solar law and strengthen it. Supervisor Tidball stated that the original solar law was done in 2016 and have since had one major solar farm completed. He invited all to attend the Comprehensive Plan Review meeting on November 21st at 5:30.
