## **Committee Reports**

Highway: Council Member Passonno reported that he had met with Highway Superintendent William Reed. In his report he stated that for the 2015-16 winter season the Department used a total of 50 tons of sand and 20 tons of salt. Recently the crew has been filling potholes and cutting back brush on Town roads.

Public Safety: Council Member Leoni discussed a misunderstanding with the UCC concerning DVAC. Apparently the UCC was not aware of the area/boundaries that DVAC covers. The Captain of DVAC has talked to the UCC directly to rectify the situation and clarify the boundaries of DVAC.

Parks: Council Member Leoni reported that a form has been published for parties wishing to participate in the Town Garage Sale/Flea Market to be held at Shafer Park on Saturday June 4<sup>th</sup>. The committee will reach out to the NYS DEC to see what other towns have done concerning the development of a kiosk structure at the Monument at the Point. It has come to the attention of the board that a permit is now required from Schenectady County for the Town of Duanesburg Summer Youth Recreation Program at a cost of \$250.00, workers need to have CPR certification and a nurse needs to be onsite. This information has been passed on to Venessa Baker so she can investigate these changes.

Sewers: #1 and #2: Council Member Potter read the Monthly Report from Mr. Warner. The DEC list of repairs and upgrades is almost complete. Manholes are being inspected for INI issues.

Sewer District #3: Bill from Delaware Engineering updated the Town Board on the progress of the project. They are working on the VanValen easement. The Pre-Bid Meeting is scheduled for Thursday April 28 at 10:00AM, with bids back by May 13, 2016. A special Town Board Meeting to go over the bids will be a possibility. This will be discussed at the Town Board Agenda Meeting on Thursday, May 5, 2016. Contracts will then be awarded to contractors and a Notice to Proceed can be issued, then contractors will then enter into a contract with the Town of Duanesburg. Early July is the projected beginning of the installation of pipes with 15,000 feet of pipe to install. It will take approximately a year and a half to complete with a projected completion date of October 31, 2017 and a 2 million dollar budget for the construction. An EFC Short Term Loan needs to be accepted by June 1, 2016.

Technology: Supervisor Tidball reported that there is a meeting later this month with the Time Warner representatives. Committee Member Annabelle Felton reported that Todd Edwards met with MetroPlex and they are interested in expanding the broadband in Princetown and Duanesburg.

### **Business Meeting:**

Resolution 90-16: Council Member Leoni motioned, seconded by Council Member Passonno to approve the hiring of Timothy Rapp as summer help with Buildings and Grounds at a rate of \$10.50 per hour not to exceed 19 hours a week. He will work from April 18 – September 2016.

Resolution 91-16: Council Member Passonno motioned, seconded by Council Member Leoni to refer the proposed Local Solar Law to the Zoning and Planning Boards for comment.

He submitted a FOIL request regarding his property and a neighboring property and a complaint that was sent on to the Ethics Board for review of a Town Official's actions. He felt the FOIL response he received was lacking information that he was entitled to. Town Attorney Terresa Bakner assured him that he had indeed received all the records he was entitled to. Supervisor Tidball commented that the original written complaint from Mr. Segrue had gone to the Ethics Board who felt the letter was enough evidence. Supervisor Tidball felt that Mr. Segure should have been interviewed by the Ethics Board. Council Member Potter and Supervisor Tidball along with one other Town Board Member will speak to the Ethics Board regarding Mr. Segrue's original complaint.

Representatives from the new Duanesburg YMCA: Dorry Foster

They wanted the residents to know the DACC was acquired by the Capital District YMCA on December 5, 2015. It offers child care and wellness programs. Dorry Foster is the Executive Director for this area. She spoke about the Summer Adventure Camp that will take place in Guilderland. They have secured funding for busing to and from the program for the children in Duanesburg.

### Cece McPhee

Mrs. McPhee wrote a letter to Senator Amedore nominating a town resident for an award recognizing outstanding citizens of the 46<sup>th</sup> Senate District. She shared that letter with the Town Board and residents in attendance.
