Committee Reports

Highway: Council Member Passonno reported he had met with Highway Superintendent Reed and provided the following report. South Shore Road gate could possibly be opened for winter plowing. The manholes also need to be brought up to grade on that road. The residents are not in favor of the road being open. The Mack truck is in Utica for scheduled service. The International truck is on the road. Equipment is being readied for the winter season. Steve Ash will return to work following back surgery on Monday, October 24 and will be assigned light duty for four weeks. Shared services with the NYSDOT are being discussed. There will be a tradeoff up to \$5000.00 in services. Attorney Bakner needs the exhibit stating what services specifically will be traded to complete the contract. The fuel oil replacement tank bids were opened last week, with the award going to Long Energy with a bid of \$5170.00. The removal of the old 500 gallon underground tank will be done by the Town of Duanesburg Highway Department The Board Recommends that Superintendent Reed undertakes the removal on the notice to the New York State Department of Environmental Conservation (which agency may send a representative to observe the tank removal) and with a consulting engineer (retained by the Town) present at the rank removal with experience in tank removal so that all the appropriate paperwork is filed with the NYSDEC and all applicable State and Federal regulations are followed. It was decided to remove the old underground tank as a precautionary measure before any issues arose. Long Energy will then install a new 1000 gallon above ground tank on a concrete slab installed by the Highway Department.

Public Safety: No report

Town Parks: Committee Member Jean Frisbee reported that the Park Committee had met with a student from SUNY Cobleskill who needed to work on a project as part of the curriculum of her program of study. She illustrated a plan, and will attend the next Park Committee Meeting to provide pricing information. A-1 has offered to provide water for one year to get the landscaping going, after that there was discussion of a portable water tank that could be used by the Town when the area is mowed. It was also suggested that the area Boy Scouts be involved in some way with the planting and upkeep of the landscaping. John Peters approached the Committee with the idea of a weekly Farmer's Market at Schafer Park next year. Committee Member Linda McCloughlin contacted the new owner of the Mariaville School regarding the donation of the playground equipment to the Town Parks. Highway Superintendent Reed repaired the entrance to Schafer Park, and was thanked for that. The Park Committee will have their yearly dinner on November 11 at 6:00PM.

Sewer Districts #1, 2 and 3: see attached reports presented by Mr. Dale Warner, Town of Duanesburg and Mr. Bill Brown of Delaware Engineering. Additionally, the contractor is on site (behind the Duanesburg Fire House) and work will begin next

week. Also, Supervisor Tidball inquired about the length of time it will take to complete the media replacement at Sewer District #1 Plant, Mr. Brown stated that it will take about two weeks. The status of the closing with EFC on the project financing for the construction of the SD#3 improvements was discussed.

Technology: Supervisor Tidball reported that the meeting with the negotiating team on Monday October 17 was more of the same. There were no answers to the questions regarding the need in our community for internet access. 120,000, 200,000, 300,000 homes to be added, Supervisor Tidball stated that the numbers are all over the place, and he has offered to sit with the group to help them get a better idea of the need in Duanesburg. He also contacted Vice President, Government Affairs for Charter Communications, Adam Falk and asked him to attend a meeting and explain to the residents what is going on. There was also discussion regarding the \$500 million the Governor promised to help fund internet connectivity in New York communities. The State representative that Supervisor Tidball spoke with stated that the Capital District will be considered in the next round of the disbursement. It could be a 50/50 match or as much as an 80/20 match. However, it does not guarantee that that cable companies will bid on the projects. The deadline for the announcement of the next phase of the \$500 million disbursement is November 30. The negotiation team represents 12-13 towns, with Duanesburg being the most active town in the group. Supervisor Tidball also questioned the possibility of no company bidding on the service for the Town. He was directed to call Ana Rua, Director of Outreach, NYS Broadband Program Office. The Town's frustration and displeasure with the negotiating was expressed, why has nothing been accomplished over the two years of talks? The Town needs to make the internet available to its residents.

Business Meeting

Resolution 130-16: Council Member Ganther motioned, seconded by Council Member Passonno to request Schenectady County to do a speed limit reduction study on Schoharie Turnpike.

Resolution 131-16: Council Member Passonno motioned, seconded by Supervisor Tidball to request Schenectady County to do a speed limit reduction study on Bramans Corners Road.

Resolution 132-16: Council Member Ganther motioned, seconded by Council Member Passonno to request Schenectady County to do a speed limit reduction study on Lake Road.

Resolution 133-16: Council Member Passonno motioned, seconded by Council Member Ganther to issue a negative declaration of environmental significance on the removal of an existing 500 gallon underground storage tank containing heating oil and to install a new, 1000 gallon aboveground storage tank which will contain heating oil and to authorize the Town Supervisor to sign the contract for the purchase of a new oil tank and related actions from Long Energy (see attached resolution). Motion carried, 3 ayes

Resolution 134-16: Council Member Ganther motioned, seconded by Council Member Passonno to authorize the Town Supervisor to accept the bid on the culvert replacement project on Wells and Brown Roads with Hubble, Incorporated, and to authorize the Town Supervisor to issue the bid award and execute a contract for the culvert replacement project (see attached resolution). Motion carried, 3 ayes

Resolution 135-16: Council Member Passonno motioned, seconded by Council Member Ganther to appoint Mr. Paul Finnegan to the seat of Vice Chairperson of the Town Planning Board.

Motion carried, 3 ayes

Resolution 136-16: Council Member Passonno motioned, seconded by Council Member Ganther to authorize the Town Supervisor to sign the Princetown Water District Outside User Agreement with the stipulation that the Agreement of the amended to require that the Agreement be filed with the Schenectady County Office of Deeds by Mr. Dusse and at Mr. Dusse's cost, to protect any future purchasers of that property on Darrow Road by giving them notice in the chain of title of the existence of the Agreement.
