Attorney Seabold, representing Mark and Kate VanWoert, spoke on their behalf regarding the abandonment of a section of Lake Connection Road. He presented the board with an aerial map and photos of the road. The VanWoerts would like to build a single family home on a piece of property that adjoins Lake Connection Road. Town Attorney

Siegel advised Attorney Seabold that the road must be inspected by the Highway Superintendent, Highway Committee or other impartial party.

Highway:

Council Member Passonno reported that paving is complete on Turnbull and Garsney Roads. South Knight and Liddle Roads are being prepared for chip sealing. The NYSDOT has denied the Town's request to erect 4 signs at the entrances to town on Routes 7 and 20 honoring Nick Gwiazdowski wrestling accomplishments. This matter will be perused by Highway Superintendent Reed. Surplus materials and vehicles are up for bid/sale on the Collar City Auction website. Council Member Potter mentioned that the Highway Department worked in conjunction with the Sewer Department on two projects over the past few weeks.

Public Safety:

Council Member Leoni reported that the UCC budget was passed at the last meeting with a 5-0 vote. The next UCC meeting will be held in October. In October Council Member Leoni will attend the Town Fire Officer's Meeting.

Parks:

The committee held a meeting on August 4, 2015. The Park Program was very successful this summer. The children enjoyed interacting with members of the New York State National Guard and the Duanesburg Ambulance Corps. A total of approximately 200 children participated in the program, averaging 20-30 per day. Council Member Leoni stated that there is a perceived lack of knowledge in the town regarding the use of the parks. They can be booked by calling the Town Clerk's office, free of charge. A kiosk will be erected at the west end of the point of Routes 7 and 20 to house the batteries or electrical service to illuminate the monument and flag. A meeting has been set with the High School Superintendent and the Art Instructor to help design the kiosk. It has been suggested that a town-wide garage sale be held next June at Schafer Park with the proceeds to benefit the Parks Fund.

Sewer District #3:

Lindsay Ostrander from Delaware Engineering brought several documents to distribute to the Town Board Members. The first she discussed was the Inland Waterbody Designation Reclassification and Sewers. Duane Lake is classified as a Class B waterbody. The document suggests that the first step of considering a sewer system for the area around Duane Lake would be to conduct an engineering evaluation and prepare a Preliminary Engineering Report for viable solutions. The second document presented to the board was the NYS Water Infrastructure Improvement Act Grant Summary Clean Water. The last few pages of the document need to be completed and returned to the NYS Environmental Facilities Corporation by September 4, 2015. Ms. Ostrander relayed some comments from Alan Tavenner, Senior Project Engineer: The alignment is almost done. The Town needs a survey to be sure all sewage runs in the proper direction to the plant. He would also like to discuss alternative insulation options for the treatment plants. He has also updated the tentative start date for SD#3 to March of 2016. There are still five property owners that have not responded to the easement requests.

Technology:

Council Member Ganther contacted Omnis regarding the installation of a WiFi system that would be accessible to the residents of the Town from the downstairs parking lot. Omnis quoted a price of approximately \$800.00. Rules and limitations need to be set and posted. He suggested that we start with accessibility during the business hours of 8:00AM-6:00PM. It would be set-up with a timer used to turn the system on and off. The Town Court offices need to be taken into consideration so the WiFi system is not running when court is in session. Council Member Ganther discussed a detailed map that Supervisor Tidball located that details the cable/broadband service in the Town. There has been no word from the NYS Senate or Assembly regarding funding for cable/broadband service funding for the Town. Time Warner negotiations will begin with a meeting on August 24, 2015. There was a meeting on July 24, 2015

to lay the ground work for the negotiations which include: funding for SHOPEG, quality of service and lowering the ration from 20 homes per mile to 15 which has been stressed as the Town's number one concern.

Business Meeting:

WHEREAS, the Town Board of the Town of Duanesburg has caused a written PHA Plan to be prepared establishing local policies for the administration of the Section 8 Housing Choice Voucher Program in accordance with regulations of the US Department of Housing and Urban Development, and has reviewed such written plan,

NOW THEREFORE, BE IT RESOLVED that the Town Board of the Town of Duanesburg herby adopts the Five Year PHA Plan starting in 2015 for operation of the Town of Duanesburg Section 8 Housing Choice Voucher Program. Motion carried, 5 ayes
