The applicant is seeking an area variance from the 20,000 sq ft limit of the Solar Local Law #2 of 2017. A site visit was conducted with the applicant determining that there were no substantial mature trees that would be removed. A written statement of the site visit has been prepared. (See attached) Planning Board will be assuming lead agent and SEQR review. The applicant has supplied all required information.

Warner Hoffman of 2245 Youngs RD- asked if his land will be affected by water runoff, he is concerned with the fact that his land is agricultural farm land.

#17-08 Largeteau, Kyle: SBL# 53.00-1-10.132, (R-2) located at McGuire School Rd is seeking a Home Occupation under section 14.5.2 (b) of the Town of Duanesburg Zoning Ordinance. Bob Merrihew gave the presentation to the Board. After much discussion the Board determined that the application did not constitute a home occupation as there is no primary residence at this time, this is a vacant lot. The Board further determined that this would not fall under a saw mill but as an agricultural use that is permitted within the R-2 zoning district.

Payst/Lack made a motion determining that the **Largeteau, Kyle** application was a permitted use in the District.

The applicant is seeking a Boundary Line adjustment from the Planning Board but require a Variance from the Zoning Board of Appeals as the pre existing structures fall short of the setback requirements for the district. The applicant is requesting Building #1 a 23 foot side yard, Building #2 a 57 foot front yard and 23 foot side yard, Building #3 a 22 foot side yard request.
